## **PART 55 - POSSESSION CLAIMS - Civil Procedure Rules**

If the tenant plans to defend the claim for possession, s/he must file a defence with the court within 14 days of receiving the claim documents. The tenant should include anything that s/he wishes the court to consider in her/his defence.

Usually tenants will have no right to remain in the property once it has been repossessed, unless the tenancy is 'binding' on the lender and in such cases the tenants can apply to the court to be joined in the possession proceedings in order to defend them.
